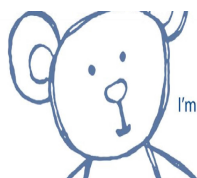

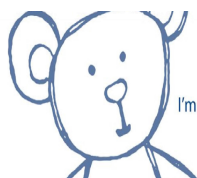
### **Implementation of the Policy**

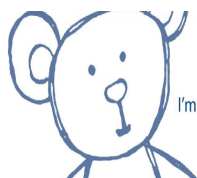
- Provide opportunities for children and adults to celebrate their cultural identity by providing a range of events and activities.

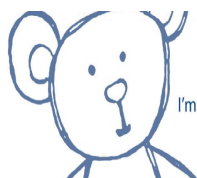
